# Warehousing Agreement QLD (Summer Crop)

### IMPORTANT GROWER INFORMATION

This document and the Receival and Warehousing Standard Terms and Conditions 2016-17 (agreement available at <a href="https://www.grainflow.com.au/growers">www.grainflow.com.au/growers</a>) constitute our agreement with the Grower identified below (you or your) in relation to the provision of receival, warehousing, storage and related services. By signing this document you agree to be bound by the Receival and Warehousing Standard Terms and Conditions 2016-17. This document must be completed prior to your first delivery. Capitalised terms not otherwise defined in this document have the meaning given to them in the Receival and Warehousing Standard Terms and Conditions 2016-17.

Storage is free for the month of delivery or part thereof (regardless of when in that month delivery occurs) and the subsequent one month. Any grain that has not been transferred to a participating marketer after the expiration of this period and remains warehoused at midnight on the last day of the second month will incur a storage fee of \$1.59 per tonne (ex GST) per month for all sorghum storage.

For example, grain delivered in February 2017 will not incur a storage fee until April 2017 (grain in warehouse midnight 31st March 2017).

Grain not transferred by midnight January 31st 2018 will incur an ongoing monthly fee of \$2.56 per tonne (ex GST) for sorghum storage.

Should you sell your warehoused grain there are several ways in which you can transfer your tickets:
