Warehousing Agreement South Australia (Winter Crop)

IMPORTANT GROWER INFORMATION

This document and the Receival and Warehousing Terms and Conditions 2022-23 (agreement available at www.grainflow.com.au/growers) constitute our agreement with the Grower identified below (you or your) in relation to the provision of receival, warehousing, storage and related services. By signing this document you agree to be bound by the Receival and Warehousing Standard Terms and Conditions 2022-23. This document must be completed prior to your first delivery. Capitalised terms not otherwise defined in this document have the meaning given to them in the Receival and Warehousing Standard Terms and Conditions 2022-23.

Storage is free for the month of delivery or part thereof (regardless of when in that month delivery occurs) and the subsequent two months. Any grain that has not been transferred to a participating marketer after the expiration of this period and remains warehoused at midnight on the last day of the third month will incur a storage fee of \$1.90 per tonne (ex GST) per month for all cereal, oilseed and pulse storage.

For example, grain delivered in December 2022 will not incur a storage fee until March 2022 (grain in warehouse midnight 28th February 2023).

Grain not transferred by midnight September 30th 2023 will incur an ongoing monthly fee of **\$3.25** per tonne (ex GST) for cereal grain and for all oilseed and pulse storage.
